## **MEMORANDUM OF UNDERSTANDING**

This **Memorandum of Understanding** (hereinafter called as the 'MOU') is entered into on this date 19/03/2025,

### **BETWEEN**

**Anekant Education Society's COLLEGE OF PHARMACY, Tandulwadi Road, (T.C. College campus) Baramati, 413102, the First Party** represented here in by its Dr. Darshan Shah (here in after referred as '**First Party**', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

### **AND**

**Mehta Hospital, Medicare Multispeciality Hospital, V.T.C. Center, Bhigwan Road, Baramati, Maharashtra 413102 the Second Party**, and (here in after referred to as "**Second Party**", Hospital which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

### **WHEREAS:**

- A) First Party is a Higher Educational Institution named: Anekant Education Society's COLLEGE OF PHARMACY Tandulwadi Road, (T.C. College campus) Baramati, 413102.
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training etc.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest.
- E) **Mehta Hospital, Medicare Multispeciality Hospital, V.T.C. Center, Bhigwan Road, Baramati, Maharashtra 413102**, the Second Party is engaged in patient healthcare and medical procedures services in the fields of healthcare, pharmaceutical and related fields.
- F) Give related information, its branches, and dimensional information about the industry concerned with whom the MoU is sworn.

**NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:**

**CLAUSE 1: CO-OPERATION**

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training etc. systems, keeping in mind the needs of the industry, the Second Party.
- 1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and

documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

## **CLAUSE 2: SCOPE OF THE MoU**

- 2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 **Hospital Visit:** Hospital and Institution interaction will give an insight into the latest developments / requirements of the hospital; the Second Party to permit the Faculty and Students of the First Party to visit its hospital.
  - 2.2.1. Counselling about hospital.
  - 2.2.2. Demonstration of various units of hospital.
  - 2.2.3. Demonstration of working of pharmacy store.
- 2.3. The Second Party will arrange **primary medical first aid training** for students and staff. (Minimum one per year)
- 2.4. The Second Party will arrange **medical check-up** of Students and Staff and this exposure provided ensuring that students and staff are in good health creates a safer and more productive learning and working environment. (Minimum one per year)
- 2.5. The Second Party will arrange **on-call medical facilities** for quick access to medical care for students and staff during emergencies also provides a sense of security, knowing that professional medical help is readily available.
- 2.6. The Second Party will arrange **vehicle** to carry the students and staff in hospital in an emergency situation.

- 2.7. The Second Party will provide discount facility to staff and their family members about 25% on the only hospital bill.
- 2.8. Staff and their family members shall be eligible for a 25% discount on the only hospital bill. To avail of this benefit, the staff member must present a valid college ID card, and family members must provide proof of their relationship.
- 2.9. **Internships and Placement of Students:** Second Party will actively engage to help the delivery of the Internship and placement of students of the First Party into internships/jobs, as per University/PCI/AICTE internship Policy. The Second Party will also register itself on University/PCI/AICTE Internship Policy Portal for disseminating the Internship opportunities available with them.
- 2.10. **Skill Development Programs:** Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them industry ready.
- 2.11. **Guest Lectures:** Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.
- 2.12. **Faculty Development Programs:** First Party and Second Party will help each other for faculty development as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.
- 2.13. Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programs on the terms specified here in
- 2.14. There is no financial commitment on the part of the Anekant Education Society's COLLEGE OF PHARMACY, Tandulwadi Road, (T.C. College campus) Baramati, 413102
- 2.15. The First Party to take up any program mentioned in the MoU. If there is any financial consideration, it will be deal separately.

### **CLAUSE 3: INTELLECTUAL PROPERTY**

- 3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

### **CLAUSE 4 VALIDITY**

- 4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period **Mehta Hospital, Medicare Multispeciality Hospital, V.T.C. Center, Bhigwan Road, Baramati, Maharashtra 413102**, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **Mehta Hospital, Medicare Multispeciality Hospital, V.T.C. Center, Bhigwan Road, Baramati, Maharashtra 413102**, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU
- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations

### **CLAUSE 5: RELATIONSHIP BETWEEN THE PARTIES**

- 5.1 It is expressly agreed that **First Party** and **Second Party** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to

extend credit on behalf of the other Party.

First Party

Second Party

Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of Baramati.




