Note:

- 1. The Ad-hoc fees declared above shall apply to the new unaided institutes starting in the Academic Year 2025-2026.
- 2. The Ad-hoc fees shall be the maximum fees to be charged to the students admitted in the academic year 2025-2026 by the newly started institutes.
- 3. The Ad-hoc fees charged to the students subject to the finalization of fees by the Fees Fixation Committee for the respective institute.
- 4. If fees decided and approved by the Fees Fixation Committee found to be less than the Ad-hoc fees charged and collected by the institute then the difference in the amount of fees to be refunded to such students by the institute.
- 5. If fees decided and approved by the Fees Fixation Committee found to be more than the Ad-hoc fees charged and collected by the institute then the institute will be entitled to claim the difference in the amount of fees from such students subject to such order to be passed by the Fees Fixation Committee.
- 6. The institute shall be under obligation to submit the proposal with the requisite documents to approve the fees charged as Ad-hoc fees and further to approve the fees for the Academic Year 2027-2028 as per the provisions under section 24 A of Maharashtra State Board of Technical Education1997 Act as amended in year 2023.
- 7. No institution shall charge the fees in any form over and above the Ad-hoc fees declared by the Fees Fixation Committee.
